## Changes to the Geberit Board of Directors

The Board of Directors of Geberit AG will nominate Thomas Bachmann for election as an independent member of the Board of Directors at the 2021 General Meeting. He is to replace Hartmut Reuter, who will be stepping down.

The Geberit AG Board of Directors will nominate Thomas Bachmann as a new independent member of the Board of Directors at the ordinary General Meeting on 14 April 2021. The nomination will be made within the context of succession planning, with Hartmut Reuter stepping down from the Board of Directors at the same General Meeting after 13 years.

Hartmut Reuter has been a member of the Board of Directors since 2008 and Vice Chairman since 2009. He is also Chairman of the Nomination and Compensation Committee and a member of the Audit Committee. He studied mechanical engineering at the Bern University of Applied Sciences (BFH) in Burgdorf (CH), has an Executive MBA from the IMD Business School in Lausanne (CH) and has held several industrial positions in marketing and sales as well as global management. From 2002, he was CEO and board member at various international companies specialising in the fields of mechanical engineering, construction supplies and laboratory technology/life sciences.

He brings with him valuable industrial experience in marketing and sales, and has contributed to the successful development of various international industrial companies as CEO and board member.
